REGISTRATION PROCEDURES

AVAT accepts applications for access to its transmission services from eligible customers or their designated agent. To acquire access to AVAT's offerings, complete the following:

1. Obtain a DUNS number (unless you already have one).
 - a. On the Internet contact www.TSIN.com for instructions on obtaining a DUNS number.
 - b. Or, call Dun & Bradstreet at 1-800-333-0505 between 8 am and 6 pm EST.
2. Register as a Transmission Customer on TSIN.com, using a unique company code.
3. Sign a Short Term Firm and Non-Firm Point-To-Point Transmission Service Agreement with AVAT. AVAT will create the Short Term Firm and Non-Firm Point-To-Point Transmission Service Agreement with the eligible customers after the eligible customer completes the Short-Term Firm and Non-Firm Service Request Information Form (see form on following page) and send the form to the Transmission Contracts Agent listed below.
4. Register with OATI webCARESTM by following the instructions in the OATI webCARESTM registration document.
5. Register your company with OATI by completing the OATI webOASIS Company Registration Form. Email the form to support@oatiinc.com
6. The OATI Support staff will process the requests during business hours (M-F 8:00 AM - 5:00 PM CT).

Important! Once you have completed the above steps and AVAT has received your executed Short Term Firm and Non-Firm Point-To-Point Transmission Service Agreement, please contact Avista Corp.
