Entergy Services, Inc. ("ESI"), on behalf of the Entergy Operating Companies, hereby submits this notice in accordance with the Federal Energy Regulatory Commission's ("Commission") March 6, 2007 letter order in Docket No. ER06-1545-002 accepting the North American Electric Reliability Council's ("NERC") revised Transmission Loading Relief ("TLR") procedures compliance filing.² In its acceptance of NERC's compliance filing, the March 6 Order triggered an obligation for transmission-owning utilities in the Eastern Interconnection to make a filing by April 5, 2007 indicating that their respective Open Access Transmission Tariffs ("OATT") should be considered modified to adopt NERC's revised TLR procedures. Accordingly, ESI hereby submits this notice stating that the Entergy Operating Companies are adopting NERC's revised TLR procedures as of the date approved by the NERC Board (August 2, 2006), and that ESI's OATT (FERC Electric Tariff, Second Revised Volume No. 3) should be deemed to be modified to incorporate the TLR procedures contained in the Version 3 Reliability Standards. NERC's previously-effective TLR procedures were originally accepted for filing by the Commission on December 16, 1998 in Docket No. EL98-52-000.3 Based on that order, ESI made a similar filing in Docket No. ER99-1299-000 indicating that Entergy's OATT should be considered modified to include NERC's TLR procedures. The Commission accepted this notice on March 12, 1999.⁴

The Entergy Operating Companies are Entergy Arkansas, Inc., Entergy Gulf States, Inc., Entergy Louisiana, LLC., Entergy Mississippi, Inc. and Entergy New Orleans, Inc.

In addition to its filing in Docket No. ER99-1299-000, ESI's OATT states that ESI "will use the NERC TLR Procedures currently in effect and accepted by FERC where the TLR Procedures would effectively relieve the constraint." Accordingly, ESI's OATT already expressly obligates the Entergy Operating Companies to use NERC's TLR procedures, as they are modified from time to time, when relieving transmission constraints. Notwithstanding, this filing clarifies that ESI now will apply NERC's revised TLR procedures as accepted by the Commission in Docket No. ER06-1545-000. To the extent that any applicable requirement should be construed to not be satisfied by this notice, ESI respectfully requests a waiver.

ESI has posted a copy of this filing on its OASIS and has provided a copy of this filing to the state and local regulators of the Entergy Operating Companies. ESI requests that the Commission waive the requirement to serve its customers pursuant to 18 C.F.R. § 385.2010 (2006) as ESI has posted the filing on its OASIS.
