Dear Secretary Bose:

Pursuant to the order issued by the Federal Energy Regulatory Commission (“Commission”) in Puget Sound Energy, Inc., 120 FERC ¶ 61,232 (2007) (the “Order”), Puget Sound Energy, Inc. (“PSE”) submits an original and six (6) copies of this compliance filing.

On September 12, 2007, the Commission issued the Order, which conditionally accepted revisions submitted by PSE under section 205 of the Federal Power Act, 16 U.S.C. § 824d, to certain provisions of PSE’s Open Access Transmission Tariff (“OATT”) that vary from the pro forma OATT as modified in Order No. 890. The Order, in part, conditionally accepted a proposed revision to the title of Schedule A-1 to PSE’s OATT to clarify its applicability. The Order (i) noted that PSE had inadvertently failed to file the tariff sheet revising the title of Schedule A-1 and (ii) directed PSE to file the required tariff sheet within fifteen days of the date of issuance of the Order.

Attached hereto are clean and redlined copies of Second Revised Sheet No. 166 superseding First Revised Sheet No. 166, which revises the title of Schedule A-1. Should you


